STANDARD FORM OF AGREEMENT BETWEEN OWNER AND CONSULTANT

1. Independent Contractor Agreement. The Company hereby agrees to employ Consultant as a consultant to perform the tasks and duties which are set forth on the Description of Duties attached hereto as Exhibit A, together with such additional duties and tasks upon which the Company and Consultant may agree (the "Consulting Services").

FORM OF CONSULTING AGREEMENT - SEC

The contract provides comprehensive contract terms and is suitable where the architect/consultant undertakes a commission for architectural services on projects using a traditional form of procurement. The RIBA Standard Professional Services Contract is an agreement with a business client or public authority and is not suitable for non-commercial work undertaken for a consumer client, such as work done to a client's home.

Consultant shall submit written, signed reports of the time spent performing Consulting Services, itemizing in reasonable detail the dates on which services were performed, the number of hours spent on such dates and a brief description of the services rendered.
